

HCBS Provider Manual Update

Office of Waiver and Facility Services

- Name has changed to Home and Community-Based Services (HCBS) Provider Manual
 - Community Long Term Care (CLTC) does not encompass all of the HCBS Waivers that the manual will cover.
 - HCBS manual will cover all 1915 (c) Waivers and Money Follows the Person (MFP) Grant program.



Covered Populations

> Level of Care (LOC) Criteria outlined.

• Eligible Providers

- > Provider Scopes Scopes for SCDHHS Contracted services only.
 - > DDSN direct enrolled providers will need to go to DDSN website for more information.
 - > Section 6 will no longer be available
 - > Scopes will be directly linked from the Manual Document.
 - > Each scope will be separate instead of one document.

• Quality Assurance

- Compliance scope:
 - Sanction update to Corrective Action Plan, Educational Intervention, 90-day suspension of new referrals and Termination
- Covered Services
 - > Updated to include all HCBS Services.



- Utilization Management
 - Discusses Service Authorization/Termination, etc.
- Reporting/Documentation
 - Confidentiality
 - Signature Policy
 - Electronic Record Keeping please note prior approval is no longer required, but scope requirements must be met.
- Billing Guidance
 - Discusses EVV and Medicaid Web Portal.
 - Links will be available for appropriate training

Scope and Standard Changes

- Across all Scopes
 - CNA Registry Check
 - Those listed with a current or expired license can be hired.
 - Those listed with a revoked license cannot be hired.
- ADHC Nursing
 - Can be authorized by physician, nurse practitioner, or physician's assistant.
 - Forms will be updated to reflect the change.
- Advanced Pest Control
 - Standards listed separately
- Attendant Care (Self-Directed)
 - Skilled services can be authorized by physician, nurse practitioner, or physician's assistant.
- Case Management
 - Zoning requirements updated to commercial or unzoned.



Scope and Standard Changes

- Companion (Agency)
 - Legally responsible guardian clarified to legally responsible adult or legal guardian.
- Environmental Modification Standards
 - Created Standards document
- Nursing Services
 - Can be authorized by physician, nurse practitioner, or physician's assistant.
 - Training requirement removed
 - PPD Requirement removed from scope
 - Legally responsible guardian clarified to legally responsible adult or legal guardian.
- Personal Care
 - Legally responsible guardian clarified to legally responsible adult or legal guardian.
 - Forms will be linked
- Pest Control
 - Created Standards Document
